Special Additional Conditions:

- i. The unit shall install the approved retrofit emission control device/equipment with at least 70% Particulate matter reduction efficiency on all DG sets with capacity of 125 KVA and above or otherwise the unit shall be shift to gas based generators within the time frame prescribed in the notification No. TNPCB/Labs/DD(L)02151/2019 dated 10.06.2020 issued by TNPCB.
- ii. The unit shall obtain No Objection Certificate (NOC) from the Tamil Nadu Bio Diversity Board /National Bio Diversity Authority if the unit is using any Biological resources or knowledge associated thereto as per the provisions of Biological Diversity Act 2002.

Additional Conditions:

1. The unit shall comply with the conditions stipulated in the Environmental clearance obtained vide MOEF & CC, GoI Letter no. J- 11011/152/2013-IA II (I) dated 07.08.2015 and 12.08.2016.
2. The unit shall operate and maintain the Air pollution control measures continuously and efficiently so that the emission shall satisfy the emission standards and AAQ standards prescribed by the Board at all times.
3. The unit shall adhere to the ambient Air Quality / Ambient Noise Level standards prescribed by the board.
4. The unit shall comply with the conditions stipulated in the NOC/Wildlife clearance obtained vide Ref.No. WL5(A)/20383/2014 dated:05.12.2018.
5. The unit shall calibrate and maintain the online monitors/sensors/etc provided at the emission sources and CAAQM Stations once in three months, so as to transmit quality data to CAC, TNPCB, Chennai and furnish report to Board.
6. The industry shall maintain a good housekeeping.
7. The industry has to ensure that its operation shall not evoke any complaints from the surroundings.
8. The unit shall comply with the provisions contained in the Ministry's OM vide F.No.22-65/2017-IA.II dated 1st May 2018, as applicable, regarding Corporate Environment Responsibility.
9. All internal roads shall be cleaned with road sweeper then and there and the house keeping should be done all the time effectively and water sprinkling shall be done frequently so as to arrest the dust spreading due to vehicular movement.
10. The unit shall ensure that the online monitoring arrangements provided for Stack are operated continuously and the data is transferred to the CAC, TNPCB, Chennai.
11. The unit shall maintain the interlocking arrangements connecting the APC measures, process safety arrangements and machineries so that if there is any defect in the APC measures, the process should get stopped.
12. The unit shall maintain connectivity to ,TNPCB ,CAC and CPCB of CAAQM stations provided on the Up wind and Downwind directions.
13. The unit shall adhere to the CPCB Guidelines on fugitive emission control vide PROBES/118/2007, dated 06.07.2007.
14. The unit shall continue to develop green belt with native species of trees to attenuate the Air/Noise pollution.
15. The unit shall ensure continuous and efficient operation of APC measures provided and take steps to control fugitive emissions efficiently during operation of unit so as to adhere to the AAQ/SM standards prescribed for Cement industries vide notification of MoEFCC,GoI dated 25.8.2014 and 9.5.2016.
16. Any fault in calibration of CAAQM stations shall be rectified immediately or data not recorded at CAC, TNPCB or due to problems at Server point shall be brought to the notice of TNPCB officials immediately and rectified.
17. This consent order does not absolve from obtaining necessary permission / clearance from other Authority or under other Statute as applicable.

1. The unit shall ensure that no trade effluent generated from the process.
2. The unit shall comply with the conditions stipulated in the Environmental clearance obtained vide MOEF & CC, GoI Letter no. J- 11011/152/2013-IA II (I) dated 07.08.2015 and 12.08.2016.
3. The unit shall comply with the conditions stipulated in the NOC/Wildlife clearance obtained vide Ref.No. WL5(A)/20383/2014 dated:05.12.2018.
4. The unit shall ensure that the sewage is treated in STP continuously and efficiently so as to satisfy the standards prescribe by the Board.
5. The Unit shall maintain log book for operation of STP.
6. The unit shall not use 'use and throwaway plastics' such as plastic sheets used for food wrapping, spreading on dining table etc., plastic plates, plastic coated tea cups, plastic tumbler, water pouches and packets, plastic straw, plastic carry bag and plastic flags irrespective of thickness, within the industry premises. Instead it shall encourage use of eco friendly alternative such as banana leaf, areca nut palm plate, stainless steel, glass, porcelain plates/cups, cloth bag, Jute bag etc.,
